"Ray exemplifies what the cooperative principals stand for and lives by them every day he is at work," Dickey said. "He started with Coffey County Electric Cooperative as an apprentice lineman 40 years ago and has always kept up on the changes within their electric system and therefore understands the entire system."

Joe Heinen, LJEC's member services director, added, "Ray always has a very genuine smile and always remembers that cooperatives are owned by their members and as a cooperative employee, we are responsible to treat all members in an equal and fair manner."

During the induction speech, Shana Read, KEC, said, "Ray's co-op involvements exemplify the cooperative principals of 'education and training' and 'commitment to the community' – and it is in these areas where he truly goes above and beyond the call. He shares his knowledge of electric cooperatives through youth education, helping those who are the next generation of co-op leaders better understand the cooperative business model and philosophy. "

Ed Wiltse, manager of Ninnescah, agreed.

"His interaction with the youth is notable.

Wiltse said. "He has the enviable ability to provide encouragement and praise while at the same time lending constructive criticism."

The KCC Hall of Fame committee elected to induct Hutson, as well as Norbert Gerstenkorn, the

former general manager of Farmers Cooperative Grain in Conway Springs, and Dale Bruce (posthumously), an attorney for many credit unions and their organizations.

Hutson and all other inductees are honored in a permanent display at the Kansas Cooperative Hall of Fame Exhibit located in the Pride of Kansas Building on the Kansas State Fairgrounds.



#### Three trustee training courses offered at KEC summer meeting

KEC will offer two Board Leadership courses and one Certified Cooperative Director course at its summer board meeting in Overland Park, KS, July 30-31.

On Saturday, July 30, trustees will have their choice between the CCD course or a Board Leadership course.

NRECA's Bob Patton will facilitate the CCD course **2620.1 Board Roles and Relationships**. This course explains how the director and the full board each play a key role in developing plans and in implementing actions to maintain and manage these relationships.

#### Students compete in ElectroRally races across the state

Kansas high school and college students are busy designing, building and racing electric vehicles for the three Kansas ElectroRally races in April and May.

The first race was April 6th at the Scott City Municipal Airport. The Western Kansas Electrorally was sponsored by Sun-

flower, its six member cooperatives and Midwest Energy.

The Touchstone ElectroRally, sponsored by Kansas Touchstone Energy Cooperatives, will be held April 19 at North Central Kansas Technical College in Beloit. The Southern Kansas ElectroRally will be held May 7 at Clearwater.

The competition is based on time and distance, and the race is won by the team that completes the most laps in one hour. The cars can reach speeds in excess of 30 mph, but strategy is just as important as speed.

Electric cooperative volunteers, including Dennis Deines of Western Cooperative Electric, help to keep the events running smoothly.

Most of the teams, including the ones that Deines works closely with, build their cars from the ground up

using lightweight components such as aluminum frames and bicycle wheels. Following the rules and guidelines of Electrathon America, the student teams stay consistent with vehicle design and composition.

"It's a good hands-on experience where the kids learn a lot," Deines

said. But he notes that "It's more than learning to build a small-scale car. It's the effort to get it funded. It's the team spirit, the travel and the bonding."

He said the students spend a considerable amount of time on the project each year and gain hands-on experience, as well as real-world skills like teamwork and dedication.

Another benefit for the participating students planning to study engineering at Kansas State University and have a 3.5 cumulative G.P.A., is that they are eligible to receive a scholarship.

"It's an incentive that promotes higher education learning and gives the students something more to work for," Deines said.

"It's a well rounded program," he added. "It's a real gratifying experience to watch the kids participate in the ElectroRally."
